b) Sent the link for the Notice convening the EGM by e-mail along with the requisite details for e-voting, to the members whose e-mail IDs are registered with the Bank/Depository Participants.

The voting on the resolutions included in the Notice can be done electronically through the remote e-voting process on the e-voting platform provided by Central Depository Services (India) Limited (CDSL).

The remote e-voting period will commence on Tuesday, January 16, 2018 at 9.30 a.m. and will end on Thursday, January 18, 2018 at 5.00 p.m., post which the e-voting module will be disabled. The facility for voting through electronic means shall also be provided at the EGM venue for members who have not already cast their votes prior to the EGM. In case of any technical failure or eventuality resulting into non-functionality of the electronic voting system at the meeting, members would be provided ballot paper for casting their votes at the EGM. Members who have already cast their vote by remote e-voting prior to the EGM may attend the EGM but shall not be entitled to vote again or change their vote at the EGM.

The voting rights of members will be reckoned as on January 12, 2018, being the cut-off date for this purpose. Any person who acquires shares of the Bank and becomes a member after dispatch of the Notice and holding shares as of the cut-off date being January 12, 2018, may obtain the User ID and the E-Voting Sequence No. for e-voting by sending an e-mail request at hdinvestors@datamaticsbpm.com. However, if the member is already registered with CDSL for remote e-voting then he/she can use the existing User ID and password for casting his/ her vote.

Details of the process/method of casting votes by members are included in the EGM Notice, which is available on the website of the Bank at




