For years, Ashok Thakor remained a phantom — until Inspector Imran Ghasura of the city crime branch and his team decided to reopen the cold case. Sub-inspector K.S. Sisodia, famous for his 'old files' expertise, took the lead. His investigation led him to dusty villages and whi-

spered clues, finally tracing Thakor to Surendranagar, where he lived a modest life selling scrap with his son.

When crime branch officers confronted him near Ratanpar bypass, Thakor initially played innocent. "I'm Ramesh Koli," he insisted.

But his son's trembling voice betrayed him, and the whole web of lies collapsed. The fugi-

tive who once snatched gold chains and spent his loot on booze and lavish meals, was now a tired man, dragging a handcart to make ends meet. But there's the twist — with both co-accused dead, many witnesses also likely deceased, and the original case file missing, the legal road ahead is murky. Sources say even the trial court has no record of the case.

Appeal

The Government of Gujarat has constituted a committee to assess the need for implementing Uniform Civil Code in Gujarat and then, based on the assessed need, suggest the contours of such a law. In the process, the committee would be reviewing the existing laws relating to regulation of personal civil matters of the residents of Gujarat.
