GENERAL BC JOSHI **MEMORIAL LECTURE 2024**

Chief of Army Staff General Upendra Dwivedi to deliver lecture at SPPU

CHIEF OF the Army Staff General Upendra Dwivedi will be delivering the General BC Joshi Memorial Lecture 2024 organised by Savitribai Phule Pune University's department of defence & strategic studies (DDSS) on Wednesday, November 27.

It will be held at the Irawati Karve social science complex in the university. The title of the lecture is 'Role and Contribution of Indian Army in Securing India's Growth Story'.

General BC Joshi commanded an Armoured Regiment in 1971 and was Military, Naval and Air Advisor in the South Pacific Region from 1973 to 1976. He was Southern and Western Army Commander from 1990-1992 and then took over as Chief of Army Staff.

He was awarded Ati Vishisht Seva Medal (AVSM) in 1982 and Param Vishisht Seva Medal (PVSM) in 1991. He passed away in November 1994 while in

The invitation shared on behalf of SPPU Vice-Chancellor Dr Suresh Gosavi explained that in 1995, Headquarters Southern Command and the University of Pune began the lecture series in honour of the memory of General BC Joshi, his contribution to higher education and furthering University-Armed Forces interaction programmes.

The University of Pune named one of its gates as General BC Joshi Dwar in 1998.

MPSC releases exam schedule for 2025; to follow UPSC pattern

THE MAHARASHTRA Public Service Commission (MPSC) has released its estimated timetable for competitive examinations in 2025, marking a sense of relief for aspiring civil servants in the state. The schedule includes key exams such

as the Maharashtra Gazetted Civil Services Combined Examination, the Civil Judge Junior Level and Judicial Magistrate First Class Examination, Group B Examination, and Group C Examination.

Notably, the MPSC Mains Examination is set to be conducted in alignment with the UPSC examination pattern. This change was originally intended for the 2023 exam cycle but was postponed in response to student demand.

While the Maharashtra Civil Services Gazetted Preliminary Exam is scheduled to be conducted on December 1, 2024, this exam faced multiple delays due to the inclusion of agriculture posts, scheduling conflicts with the IBPS exams and the implementation of the code of conduct for Assembly elections.

The MPSC has released the hall tickets for the said exam and aspirants are advised to print them in advance.


