<u>Identity Proof</u> -- Any of the below with self-attestation and OSV done by the RM.

- I. PAN Card Copy
- II. ELECTION VOTER ID
- III. DRIVING LICENCE
- IV. GOVT ISSUED ID CARD WITH PHOTO AFFIXED.
- V. BANK PASSBOOK COPY WITH PHOTO AFFIXED
- VI. PASSPORT COPY

Following documents are required for change of tax status from Minor to Major

- 1) New Bank A/c cancelled cheque with pre-printed name along with tax status mentioned on the Cheque or BANK STATEMENT and Bank letter with customer's tax status mentioned and branch manager's attestation.
- 2) In case of change in Bank A/c, please provide old & new cancelled Cheque copy
- 3) Pan card copy
- 4) KYC status printout
- 5) FATCA declaration completely filled form

******NOTE-- Provide a separate request for Nominee updation -mandatory
